In order to abide by the constitution, rules and policies of the Australian Labradoodle Association (ALA) and any disciplinary action as well as be responsible for accurately representing, promoting and protecting the Australian Labradoodle breed, members will:

| 1.5.0 | Obtain written approval of the ALA Executive Committee for any variation to the Rules and Regulations – there are a limited number of rules where an exemption may be granted. Refer to ALA Executive Exemptions | 2.27 | Fine level according to R/R breached |
| 1.6.0 | Not provide promotional communications or publications in verbal, print, or electronic formats representing the opinions of the ALA and its membership without written permission from the ALA Executive Committee. | 2.19 | High |
| 1.7.2015 | Treat the access and content of the ALA Register with confidentiality - this includes but is not limited to downloading and sharing health test results belonging to others, with non-ALA members. | 2.32 | Mid |

¹ Rule numbering comprises of three parts:

- the first number relates to the aspect of the Code of Ethics (COE) the rule falls under (1-5)
- the second number is the rule number (within that element of the Code of Ethics) (1-∞)
- the third number relates to the year of revision with zero indicating the rule originated in initial Rules and Regulations (RRs) or COE document.

| 2a.1.0 | Ensure a bitch is not bred or in whelp prior to 12 months of age. | 1.06 | High |
| 2a.2.0 | Ensure a bitch will not have more than 2 litters in an 18 month period unless local regulations require a higher standard. | 1.21 | High |
| 2a.3.0 | Ensure a bitch will not be bred for more than 4 litters without veterinary certification for fitness and not more than 5 litters in total. | 1.22 | High |
| 2a.4.0 | Not breed a bitch beyond her 6th birthday - she may whelp after her 6th birthday as long as she is not mated after this time. | 1.23 | High |
| 2a.5.2014 | Notify the ALA Registrar in writing of any dogs bred by the day of whelping. | | Low |
| 2a.6.2014 | Verify parentage through DNA profiling before issuing a pedigree for any offspring where more than one sire covers or may have covered a bitch unless DNA for colour excludes a particular sire. | 2.33 | High |
| 2a.7.0 | Notify the ALA Executive in writing on becoming aware of a pairing that produces a puppy/dog with a life inhibiting genetic defect in a program and ensure that this pairing is not repeated ⁴ . The information to be provided to the ALA includes: Sire, Dam, affected pup name/s and date of birth. | 2.23 2.24 | Mid |
| 2a.8.2014 | At no time have more than 5 litters on the ground from the day of whelping to 8 weeks of age. A grace period of 1 week is permissible for a 6 th litter to allow for litters arriving late or early. | 2.30 | High |
| 2a.9.0 | Use Australian Labradoodles, Origin Labradoodles, parent breeds and parent breed infusions consistent with the current membership approved ALA Breed Infusion Guidelines and ALA Grading Schemes. | 2.3 | High |
| 2a.10.2017 | Pregnant bitches being transported by air must travel at least 14 days prior to their due date based on a 63 day gestation period post ovulation. Breeders must inform the ALA Registrar at the time of breeding notification of the breeder's intention to transport the bitch during pregnancy. | | High |

⁴ Notifications and management of future pairings are the responsibility of the breeder who has been involved in the pairing resulting in a life inhibiting genetic defect – specifically the stud and /or bitch owner and/or leasee/s. Breeders may report to the Executive other defects they are aware of if they believe this information has not yet been provided.

| | Provide written details of dietary, training, general and veterinary care required for the Australian Labradoodle that is given to purchasers as well as the puppy Health Guarantee: <ul style="list-style-type: none"> A copy will be lodged with the ALA New Breeder Coordinator prior to releasing puppies to new homes from the first litter as an ALA member and where major revisions are made; A copy of the Health Guarantee will be available to purchasers prior to taking any payment. | 2.02 2.03 | Mid |
| 2b.2.0 | Offer a Health Guarantee that covers puppies against any life inhibiting genetic defects for a minimum of 2 years from the date of birth. The guarantee will not require the return of a dog nor depend on unverifiable conditions to be met. It will outline the undertaking to either replace, refund all or part of the initial purchase price within 30 days and to provide moral support. | 1.16 | High |
| 2b.3.0 | Retain puppies within care for a minimum of 8 weeks (56 days) before they transition to a new home. | 1.09 | High |
| 2b.4.0 | Never sell, trade or raffle a dog/ puppy to any commercial animal wholesalers or retail pet dealers/traders. | 1.07 | High |
| 2b.5.0 | Desex or render incapable of breeding (by gonad sparing sterilisation) ALL puppies before they leave care, except if dog is sold or traded as a breeding prospect. If surgery must be deferred due to a puppy's current health as recommended by a registered veterinarian a spay/neuter contract that prohibit the mating of the dog will be issued with desexing required by the time the puppy turns 5 months of age | 1.10 | High |
| 2.14.0 | To the best of their ability, ensure that all persons acquiring dogs clearly understand their responsibility for the care and welfare of the animal and have made the necessary preparations for keeping the dog. | 1.12 | High |
| 2b.6.0 | Offer to take back or assist in re-homing any puppy or dog if advised that the dog becomes unwanted or unable to be cared for by the purchaser, for any reason and at any time. | 1.14 | High |
| 2b.7.0 | Obtain veterinary advice before euthanizing any puppy or dog. | 1.08 | High |

| 3.3.2014 | Ensure any dog that has carrier or affected status for any hereditary disease in the full breed profile list, or has an incomplete full breed profile is only permitted to breed to dogs that are clear for that particular disease. | 2.09 | High |
| 3.4.0 | Refrain from breeding with any dog diagnosed with dysplasia (hip and / or elbow) | 2.07 | High |

| 1.11 | I shall wean, give appropriate worming and vaccinations to all puppies while in my care. | Covered in Code (2) – refer to local level government / welfare requirements |
| 2.17 | I shall display the ALA's Accredited Breeders logo on <i>any promotional publications</i> including my website and will add a link to the ALA home page. | Difficult to monitor compliance (note italics) |
| 2.12 | Remain aware of current AVA hip score average for the Australian Labradoodle and acknowledge that it is considered a high risk to breed a dog with a score of 4 or more on either hip in any of the nine areas evaluated using this method. | Knowing scores does not improve breeding practices – 3.4.0 addresses desired practices |
| 2.26 | I shall return all ALA registrations, if I am lifetime suspended. | Not able to be effected as we no longer have jurisdiction over a suspended member |

| 2.28 | I shall not lease any dogs that belong to another ALA breeder who is under suspension or deactivation. | Relaxed position – there may be good reason to use a deactivated members dog providing it fulfills health and registration requirements |
| 2.29 | Grading can be altered by the registrar within the first 6 months of issuance or with the written permission of the breeder of the dog whose grading is in question, or by signed statement of 3 private parties who can provide valid proof of reason to alter. | Registrar confirms grading and has jurisdiction to alter in consultation with Breeder / Executive. |
